<b>POST: Midday Supervisory Assistant</b>

<b>JOB PURPOSE:</b>	To work as part of a team monitoring pupil behaviour during the midday break to ensure a caring and safe environment.
<b>JOB CONTEXT:</b>	<p>Required to work indoors and outdoors when supervising the children and young people to ensure their safety.</p> <p>This school is committed to safeguarding and promoting the welfare of our pupils and young people. We have a robust Child Protection Policy and all staff will receive training relevant to their role at induction and throughout employment at the School. We expect all staff and volunteers to share this commitment. Operational Issues	<ul style="list-style-type: none"> <li>• Supervise the playground area, playing field, cloakrooms and classrooms etc during the lunchtime break.</li> <li>• Support children in their play by suggesting games and encouraging participation.</li> <li>• Assist with the removal of food and equipment once pupils have eaten their lunch.</li> <li>• Deal with minor first aid incidents; follow appropriate procedures for recording and reporting.</li> <li>• Assist in the implementation of appropriate behaviour management strategies as required</li> <li>• Observe a child or young person's behaviour, understand its context, and notice any unexpected changes and report any inappropriate behaviour to the correct member of staff.</li> <li>• Resolve minor disputes between pupils</li> <li>• Assist in the supervision of other activities during the midday break, including setting out and storing equipment</li> </ul>
Communications	<ul style="list-style-type: none"> <li>• Establish rapport and respectful, trusting relationships with children, young people and those caring for them.</li> <li>• Report any concerns about pupil welfare to the appropriate member of staff in a confidential manner.</li> </ul>
